Personal data processing notice

Pursuant to Art. 13 of legislative decree 196/2003 applicants are hereby informed that Biblioteca Universitaria di Bologna and its history archive will process the data supplied by you exclusively for institutional purposes and, in particular, to ensure the provision of consultation services in accordance with data protection laws. In particular, this data will be processed, including by electronic means, by entities specifically appointed for the task by the president of Biblioteca Universitaria di Bologna for user statistic purposes.

Supplying data is not mandatory but any failure to do so will make consultation and reproduction of the material conserved in the Biblioteca Universitaria di Bologna and its history archive impossible.

Pursuant to Art. 7 of legislative decree 196/2003 users can, at any time, obtain information on the processing of their data and its methods and purposes and the logic used in this as well as:

1. confirmation of the existence of the data and its communication and origin;
2. the details of the data controller and those responsible for processing it as well as the entities and categories of entities to whom this data can be passed on or who may come into contact with it in their capacity as controllers or those appointed by the latter;
3. updating, correction and supplementing of the data;
4. cancellation, transformation into anonymous form and blocking of any data processed unlawfully;
5. certification that those whose data have been communicated and disseminated in the operations cited in points 3 and 4 have been notified, with the exception of cases in which this is impossible or involves means manifestly disproportionate to the right safeguarded;
6. the opportunity to contest data processing even if pertinent to the purpose of data collection, on legitimate grounds, for commercial information or market research purposes.
